
Assembly Steps

Step 1: Install the Desk Feet

Attach the desk foot (1) to the lifting columns (2 & 3) using 8 M6 bolts (E) and 5x5 hex key (A).

Loosen the 4 bolts in the crossbeam (6) with 4x4 hex key (A), then stretch the crossbeam out.







Step 4: Install the Transmisson rod

To install the transmission rod (5), first slot it into lifting column (2) and loosen the hex bolt (Figure. 1). Extend the transmission rod and slot it into the motor on lifting column (3), then tighten it down with the included 2.5×2.5 hex key (A) (Figure. 2)







Step 7: Install the Desktop

Adjust the length of transmission rod and crossbeam, carefully line up the frame to match the pre-drilled holes. Attach the frame to the desktop using ST4.2 screws (D) and tighten with drill.


Step 9: Install the Keypad

Install the kaypad (10) with ST4.2 screw (14).











Step 8: Tighten the Crossbeam and Transmission Rod

Tighten down the 4 bolts in the crossbeam with the 4x4 hex key (A), and the hex bolt in the middle of the transmission rod with the wrench (G).













Attach the baffle (7) to the crossbeam using M4 bolts (B) and tighten with 2.5x2.5 hex key (A).






The cable tie (13) can be used to fasten the cables to the desktop and keep the cables organized.







- b. At the lowest position, press and hold the "-" key for 3 seconds; the display will show " r5t ". Repeat step a to complete the reset.

• Anti-collision function: The desk will stop automatically when an obstruction is detected while the desk height adjustment is in motion.

 Adjust the Sensitivity of Anti-collision:



Keep pressing "+" and "-" button at the same time for 3 seconds to switch the sensitivity. One operation to switch to one gear, a total of 4 gears (R-0, R-1, 8-2,8-3);

"R- I", low sensitivity;

"R-2", middle sensitivity;

"R-3", high sensitivity;

"R-D", switch off the anti-collision function.

(Before switching off the function please make sure there aren't any object under the desk to prevent potential damage.)

• Troubleshooting:



- a. When the error code E01 or E02 occurs, please retry after more than 18
- b. When other error codes occur and the "-" button doesn't work, please confirm the cable is not damaged and is well connected and then cut off the power for more than 10 seconds. Reconnect to the power and LED display shows "rst", then start the reset process by pressing and holding the "-" button. c. If our troubleshooting tips don't yield any success, please contact the customer service.
